## **MINUTES**

Motion by Director Shafer to approve the minutes of the regular Board Meeting dated February 16, 2023 as presented. Motion carried unanimously.

#### **FINANCIAL REVIEW**

Revenue for the month of February totaled \$194,512 with the majority coming from current year taxes, interest income, and FEMA SAFER grant funding.

Expenditures for the month of February totaled \$1,170,000 with personnel services at \$892,000 and materials and services at \$278,000.

Accounts payable equated to \$420,900 with noteworthy items being the EMS pediatric bags, replacement of the Dodge Bridge well pump, and forklift repair.

Motion by Director Dimick to approve the Accounts Payable and the Revenue/Expenditure reports for February 2023. Motion carried unanimously.

# **INFORMATION ITEMS**

#### **DEPUTY CHIEF BATES**

Deputy Chief Bates shared a page of data and analytics up of all call types and responses to this date produced by Data Systems Specialist Shannon Deutschman. This document is designed to update the Board regarding the Districts response activities.

Bates shared the District is in EMS recertification period. The Community Care team has been integral in helping the members obtain their required hours.

Bates shared the probationary firefighters have completed their required practical and written exams and tasks.

Bates shared that Community Care interviews took place, moving one person into backgrounds. Next week will be Chief interviews for firefighter interviewing the top 14 ranked individuals from the current register. There is one vacancy due to Firefighter Brite's retirement and forecasting into the next 12-18 months.

Bates shared information regarding the movement of the two tenders that have been surplused.

## **DIVISION CHIEF PATTERSON**

Division Chief Patterson shared that DFM Northrop will be providing fire extinguisher training to adult foster homes in the community.

Patterson shared the Northwest Youth Corp is stationed at Dodge Bridge again this year and they have already begun working on fuels reduction in the area.

Patterson shared the Agate Lake project has begun with approximately 220 homes available. 75 homes have signed up through Community Connect. This project is funded by a \$350,000 grant obtained by ODF for fuels reduction efforts helping the community.
