President Tonn called the meeting to order at 5:16 p.m. pursuant to ORS 192.640 and as advertised in the Mail Tribune dated January 9, 2020.

### **MINUTES**

Motion by Director Leavens to approve the regular Board minutes dated December 19, 2019 as presented. Motion carried unanimously.

### **FINANCIAL REVIEW**

Revenue for the month of December totaled \$10,983,130. Revenue resulted from current year taxes.

Expenditures for the month of December totaled \$632,700. Expenses were routine in nature. Noteworthy expenditures were ImageTrend and International Public Safety Data Institute for the records management system and the final payment for the budgeted SCBAs.

Motion by Director Hauser to approve the Accounts Payable and the Revenue/Expenditure reports for December 2019. Motion carried unanimously.

### **PUBLIC COMMENT**

Chaplain Myers publically thanked everyone for the donation of the car. Firefighter Patrick Bailey organized the purchase through donations. The firefighter family truly cares.

### **INFORMATION ITEMS**

### **EXECUTIVE REPORT**

Fire Chief Horton gave a progress report on the current Strategic Plan. The District is in year three of the three year plan. Goals have been completed in all five of the strategic initiatives. The District will begin the process of a new strategic plan in the fall.

Horton shared the updated Organizational Chart effective on January 1, 2020 reflecting the part-time Community Engagement Coordinator, the future Community Risk Reduction membership, and the reorganization of the Fire and Life Safety Division into Strategic Services. The Organizational chart is depicted in two perspectives; Personnel Accountability and Functional Responsibility.

Horton shared that legislative season began. The office of emergency management could be taken out from under the military and into their own state department, the same approach for the office of the state fire marshal which falls under the state police, and committees have been meeting regarding the Governor's Wildfire Council.

Horton shared that the memorial for Battalion Chief Rod Edwards was a moving service and several members were able to attend the service for the first Fire Chief, Richard Krupp who passed away.

Horton shared the ASA Ordinance revision meeting is scheduled for February 11, 2020 to evaluate the experiences that the system had during 2019 and determine the next steps. ECSO is hosting consultants to provide training and guidance to agency partners, ECSO dispatch, and the entire EMS community for a review of the ASA Ordinance and system.

### **OPERATIONS**

Deputy Chief Hussey shared that Supervising Physician Dr. Kellerher, and Firefighters Kelly Harrington and Mark Tomasello met with Mercy Flights to collaborate on 34 revisions to the EMS protocols that will take affect February 1, 2020.

Hussey shared Captain TJ Lockwood and his crew recently welcomed Senator Golden on a ride-along and answered questions concerning the area wildfire situation.

### TRAINING AND SAFETY

Division Chief Blakely shared that the joint Firefighter Recruit Academy with Medford Fire –Rescue begins on Monday, February 3<sup>rd</sup> introducing Firefighter Rob Miller as the Academy Coordinator for Fire District 3 with eight total recruits.

Blakely shared that the new training plan has begun with an opportunity to interact with the Target Solutions program.

Blakely shared that there were no injuries or near misses at the beginning of the year.

### **FIRE AND LIFE SAFETY**

Fire Marshal Patterson shared the accomplishments of the division in December noting that five separate fires took place at the same address in December. The District is currently working with the sheriff's department to determine what can be done in the future. In 2019, 1,015 smoke alarms were installed by on-duty crews and during separate events.

Patterson gave a quick update on the Scenic fire station stating that the avenue work continues with two lanes of traffic open.

### STRATEGIC SERVICES

Deputy Chief Bates shared that on January 1<sup>st</sup>, the District began using ImageTrend for the reporting software that is IPad based and the SCBA's are now in service.

Bates shared the Local Emergency Planning Committee (LEPC) plans what the area would do during a major natural event. The first LEPC meeting will be next week, this is the first time the valley has had this type of group.

Bates shared that the Community Care Units have moved forward and will be introduced during an update to the Budget Committee later this month.

Bates shared the work that the SOU Intern has been doing in Gold Hill with Resident Volunteer Jordan Bates to determine the community risk in the area and what action will need to take place to reduce risk.

### **2019 OREGON FIRE CODE**

Fire Marshal Patterson explained the significant changes to the 2019 Oregon Fire Code (OFC) which establishes minimum fire safety requirements as well as addressing fire prevention, fire protection, life safety, safe storage, and use of hazardous materials. The OFC provides a total approach toward controlling hazards in all buildings and sites, regardless of the hazard being indoors or outdoors.

The ordinance process will begin at the February Board meeting.

## **ORDINANCE No. 22**

### TITLE:

IN ACCORDANCE WITH OREGON REVISED STATUTES 198.510 TO 198.600; AN ORDIANCE ADOPTING FIRE CODES AND STANDARDS FOR JACKSON COUNTY FIRE DISTRICT 3, PROVIDING MINIMUM STANDARDS FOR A REASONABLE LEVEL OF LIFE SAFETY AND PROPERTY PROTECTION FROM THE HAZARDS OF FIRE, EXPLOSION OR DANGEROUS CONDITIONS IN NEW AND EXISTING BUILDINGS, STRUCTURES AND PREMISES AND TO PROVIDE SAFETY TO FIRE FIGHTERS AND EMERGENCY RESPONDERS DURING EMERGENCY OPERATIONS, AND REPEALING ORDINACE NO. 21.

WHEREAS, The Oregon Office of State Fire Marshal, in accordance with Oregon Revised Statute (ORS) 476.030, has amended and adopted the International Fire Code, 2018 edition, establishing the 2019 Oregon Fire Code; and,

WHEREAS, Jackson County Fire District 3 (the District) operates as an Exempt Jurisdiction in accordance with ORS 476.030(3); and,

WHEREAS, The Oregon Office of State Fire Marshal has designated the Fire Marshal of Jackson County Fire District 3 as the Fire Code Official and as the approved local authority for exercising functions relating to fire prevention, fire safety measures and building construction; and,

WHEREAS, The Board of Directors for the District, in accordance with ORS 478.910, finds the need for prescribing and enforcing regulations that govern conditions which may be hazardous to life and property from fire and explosions; and now, therefore;

### IT IS ORDAINED AS FOLLOWS:

### FILING:

This ordinance, including the codes hereby adopted, shall be filed in the record of the District and in the office of Jackson Count Clerk and Oregon Office of State Fire Marshal as prescribed by ORS 478.940. A copy shall be posted at each fire station within the District. From the date on which this ordinance shall take effect, provisions thereof shall be controlling within the territorial limits of the District and within each city and county within the District approving the provisions of the Oregon Fire Code pursuant to ORS 478.924. The whole of this ordinance shall be known as the Fire Prevention Code and may be referred to as the Fire Code and shall be enforced by the Fire Code Official of the Fire District in accordance with ORS 478.920.

### **SCOPE:**

The purpose of this code is to establish the minimum requirements consistent with nationally recognized good practice for providing a reasonable level of life safety and property protection from the hazards of fire, explosion and dangerous conditions in new and existing buildings, structures and

premises and to provide safety to firefighters and emergency responders during emergency operations as authorized by ORS 478.910.

### SECTION I – ADOPTION OF THE 2019 OREGON FIRE CODE

The 2019 Oregon Fire Code is hereby adopted by the District for the purpose of prescribing regulations governing conditions hazardous to life and property from fire or explosion.

### **SECTION II – ENFORCEMENT OF CODE**

Notwithstanding provisions in the 2019 Oregon Fire Code authorizing or requiring inspections of buildings and premises or testing of fire protection systems and equipment, or provisions providing for enforcement of the Fire Code, such inspections, testing and enforcement of the Fire Code shall be discretionary by the District Fire Chief and other individuals charged by the Fire Chief with such activities. The District recognizes that is has limited financial resources with which to provide fire, rescue and other services and functions and is forced to make public policy decisions as to allocation of District resources. Although the District places a high priority on prevention, inspection and maintenance of fire systems, due to financial limitations, it is the Board's policy to require inspections only so often as necessary to provide a reasonable level of fire and life safety. Accordingly, although the Fire Chief and other individuals charged by the Fire Chief with these activities are encouraged to pursue them, performing such activities, as well as the scope and frequency of such activities shall be within the discretion of the Fire Chief. It is the intention of the District to make clear that the District's duty to perform the inspections and testing, or to take enforcement actions, as set forth in the Fire Code is limited to providing a reasonable level of fire and life safety. Such actions by the District are discretionary.

## SECTION III – JACKSON COUNTY FIRE DISTRICT 3 SPECIFIC ADOPTIONS AND AMENDEMENTS INCLUDED WITH THE 2019 OREGON FIRE CODE

The District hereby specifically adopts the following Appendices of the 2019 Oregon Fire Code:

Appendix A- Board of Appeals

Appendix F- Hazard Ranking

Appendix I- Fire Protection Systems-Noncompliant Conditions

### **SECTION IV – PENALTIES**

Any person who violates any of the provisions of these regulations hereby adopted or fails to comply therewith, or violates or fails to comply with any order made thereunder, or who builds in violation of any detailed statements, specification or plans submitted and approved thereunder and from which no appeal has been taken, or shall fail to comply with such an order as affirmed or modified by the Board of Appeals or by a court of competent jurisdiction within the time affixed herein, shall severally, for each and every such violation and non-compliance respectively, be guilty of a violation of the Fire Prevention Code as provided in ORS 478.930, punishable upon conviction as prescribed by ORS 478.990. All fines or punishments authorized upon conviction shall include the costs to the District to remedy the violation including costs of towing, storage or removal of the hazard or obstruction if necessary.

The Fire Chief or designated representative may bring a compliant in law or in equity to alleviate a violation of this ordinance as well as in addition to the rights to enforce said ordinance under the provisions of ORS 478.930 and ORS 478.990.

### SECTION V – FIRE CODE BOARD OF APPEALS

As authorized by ORS 479.180, the District may establish, as needed, a board of appeals. Such board of appeals may be implemented through bylaws and other procedures adopted by ordinance of the District. In the event the fire district Board establishes a board of appeals, the provisions of this ordinance, where appropriate, are subject to the board of appeals procedures.

### SECTION VI – REPEAL OF CONFLICTING ORDINANCES

The provisions of this Ordinance shall be controlling within the territorial limits of the District and within each city and county within the District approving the Fire Code pursuant to ORS 478.924. The existing fire code, Ordinance No. 21, has been approved within the county and each city within the District. The District desires that the existing fire code continue in effect until such time as the cities and counties within the District have approved this new Fire Code pursuant to ORS 478.924. Accordingly, Ordinance No. 21, and all former ordinances or parts thereof, which are conflicting or inconsistent with the provisions of this Ordinance or of the code or standards hereby adopted, are hereby repealed, effective on the date of this Ordinance; provided, however, that Ordinance No. 21 shall continue in effect in the county and each city which has approved it until the city or county approves this Ordinance No. 22. Further, prosecutions or violations under repealed ordinances may continue after the effective date of this ordinance.

### **SECTION VII – VALIDITY**

The District hereby declares that should any section, paragraph, sentence or word of this Ordinance or of the Fire Code or standards hereby adopted be declared for any reason to be invalid, it is the intent of the District that it would have passed all other portions of this ordinance independent of the elimination of any such portion as may be declared invalid.

### SECTION VIII – DATE OF EFFECT

The Board of Directors of the Fire District finds and determines that it is necessary and expedient that the provisions of this ordinance become effective 30 days following adoption, as authorized by ORS 198.570

### ORDINANCES AND RESOLUTIONS

**Relative Information:** The general form for taking action on business items involves the passing of motions. In certain situations the Board may find the need to adopt an ordinance or a resolution.

An ordinance is an authoritative rule or law adopted by the Board in conjunction with State Law. The District adopts ordinances that include the adoption of a fire code, collection of fees, formation of a contract review board, prohibition of volunteers and employees from being Directors, requirements for insurance of public firework displays, and medical and fire stand-bys at certain events. Oregon Law provides specific procedures that must be followed in the advertisement and adoption of ordinances. Ordinances are effective until repealed.

A resolution is a formal motion that expresses formal opinion. The District adopts resolutions in the same manner as all main motions. In general, the District utilizes resolutions when required by law or when the proposal is lengthy and/or highly important. Resolutions are usually prefaced with *whereas* statements, that state the reasons for the resolution. Resolutions remain in force until rescinded or for the length of time specified in the resolution.

**Policy Statement:** It is the policy of the Board of Directors to utilize Ordinances and Resolutions in accordance with their intended purpose and to review, amend and/or delete as may be indicated.
