President Tonn called the meeting to order at 5:17 p.m. pursuant to ORS 192.640 and as advertised in the Mail Tribune dated October 11, 2018.

MINUTES

Motion by Director Dimick to approve the regular Board minutes and the Executive Session minutes dated September 20, 2018. Motion carried unanimously.

FINANCIAL REVIEW

Revenue for the month of September totaled \$61,625. The majority from prior year taxes and reimbursement from OSFM for the Graham Fire in Redding.

Expenditures for the month of September totaled \$885,865. Accounts Payable expenditures totaled \$232,532. Noteworthy expenditures were the replacement of the well pump at the Sams Valley station and septic tank improvements at the Gold Hill station. Significant Capital project expenses toward equipment for the two new engines and the RCC Educational Facility.

Motion by Director Shafer to approve the Accounts Payable and the Revenue/Expenditure reports for September 2018. Motion carried unanimously.

INFORMATION ITEMS

EXECUTIVE REPORT

Fire Chief Horton shared a strategic plan update with the Board outlining the tasks that have been completed and those that are in process as of September 2018. Horton highlighted specific objectives and the work that is being accomplished to achieve the tasks identified under the five different initiatives. Horton recognized IT Rydings and the work accomplished on a performance measurement reports to meet the objective to produce and relay readily available data for the organizations management, District Intern, Cora Jacobi who is identifying the District's changing needs with social media, and Chief Hussey who has been very successful engaging positive communication and dialogue with the District's law enforcement agencies.

Horton shared he attended a conference hosted by the Western Fire Chief's Association focusing on succession planning.

OPERATIONS/SUPPORT SERVICES

Deputy Chief Hussey shared that student Joshua Brite will take residency of the second Dodge Bridge house. All current locations have residents.

Hussey shared that the High School Academy will begin next week with positive interest from the Eagle Point, Crater, North Medford, and Phoenix High Schools.

Hussey shared that a team will go to Wisconsin for the final inspection of the engines and the final specs for the Type 3 engines for the initial quote will go out in the near future.

Hussey shared one of the budgeted radio cache's that can be taken to fire incidents allowing crews to have full communication capabilities with incidents.

FIRE AND LIFE SAFETY

Deputy Chief Patterson shared the September recap of the Fire and Life Safety Department.

Patterson shared that next month the Target Hazard Tour will be at Northwest Coatings on November 26th, 27th, and 29th.

Patterson shared that CPR Anytime classes have been scheduled and the elementary education classes are almost completed.

CONSRUCTION PROJECTS

Deputy Chief Patterson shared that the RCC Educational Facility is moving along with the hope to occupy the building at the end of January.

Patterson shared that Chief Horton signed the architectural contract for Scenic Avenue Fire Station with Soderstrom Architects stating the amount is not to exceed the for time and materials rather than a gross maximum price.

Patterson shared that the Eagle Point seismic is complete, the Central Point seismic is in process, and the Agate Lake seismic began today.

TRAINING AND SAFETY

Deputy Chief Hussey shared that 97% of District personnel have completed the 2018 OR-OSHA mandatory training during the 3rd quarter.

Hussey shared that the Safety Committee has evaluated new brush gear that can be worn on response to medical aids, technical rescue events, MVC's, and vehicle fires. The Safety Committee also experienced a noticeable improvement in reporting and documenting injury events based on the changes made to the reporting practices and thanked CAO Maxwell, Finance Assistant Giles, and the committee for their work in updating the forms and the process.

Deputy Chief Hussey gave an update on the Firefighter exam process; The District received 75 applications, 59 candidates have been invited to participate in the physical agility test (PAT). The top 48 candidates will proceed to the skills assessment center November 5-8, 2018.

Chief Horton, Director Hauser, and Executive Assistant Calvert reviewed the SDAO Best Practices Checklist. Chief Horton shared the District has received the full 10% credit on next year's SDIS property/casualty insurance contribution.



BOARD APPOINTMENTS

<u>Relative Information</u>: The appointment of committees and/or representatives is a routine function of a board. Ordinarily the Board President will make the appointments with the concurrence of the full Board. The appointees may be Board, Staff, and/or citizen appointments depending on the position.

Appointments are made in response to statutory requirements (Civil Service Commission, Budget Committee), to study specific issues (Salary & Benefits Committee), or to represent the District in associations or other interagency activities (Emergency Communications of Southern Oregon).

The particular authority and duties of appointees whether a Director, District staff member, or citizen are either specified by statutory requirements or will be set by the Board President at the time of appointment.

Board appointments may be ad hoc or ongoing. Current ongoing appointments include the following:

- A. Civil Service Commission three (3) citizen members with four-year terms.
- B. Budget Committee five (5) citizen members with three-year terms.
- C. Non-Bargaining Group Salary & Benefits Committee two (2) Board Directors at the President's discretion.
- D. Emergency Communications of Southern Oregon one (1) Board or Staff member at the President's discretion and one alternate.

While the committees required by state law may have specific selection criteria, the Board generally has broad discretionary authority in the process.

The following process is used when making citizen appointments to the Civil Service Commission and the Budget Committee:

- 1. Advertise the vacancy to identify qualified applicants.
- 2. Review applicants for qualifications.
- 3. Interview qualified applicants as may be necessary.
- 4. Make selection and appointment in a manner selected by the Board.
- 5. Conduct orientation and/or training as may be necessary.

An appointment of a Director or District staff member to represent the Fire District or the Board of Directors should be based on qualifications and availability. Final appointments are the responsibility of the Board President.

Policy Statement: It is the policy of the Board of Directors to make appointments to various committees and commissions as stated in this policy.

School District 6, Jackson County Fire District 3, and Housing Authority of Jackson County own adjacent parcels of land along Scenic Avenue in Central Point. Specific to this Agreement are Tax Lots (TL) 4400, 4600, and 4700 on Jackson County Map 372W03AB. School District 6 has owned TL 4400 for many years. District 3 purchased TL 4500 & 4600 in the spring of 2018 with the intent of constructing a new fire station. Housing Authority purchased TL 4700 in the summer of 2018 with the intent of expanding their current Scenic Avenue multi-family housing complex (see map 1).

It is understood that Scenic Avenue is congested at times. The traffic flow for the middle school is in need of attention and solution. The new fire station needs unobstructed access to Scenic Avenue. The Housing Authority will benefit from additional access to their new complex. These entities find it advantageous to partner together and help solve the current and future traffic issues associated with the anticipated uses of their properties. The partners intend to complete mutually beneficial construction projects and land ownership transfers. This Memorandum of Agreement will help define the intents of this partnership and serve as a guide during land development, planning, and crafting of legal transactions.

In consideration of a new access road to be developed and constructed by Fire District 3 and Housing Authority of Jackson County which will connect Scenic Avenue to Scenic Middle School the following considerations are understood:

- The new road will connect Scenic Avenue to Scenic Middle School at a point across from Rock Way.
- The new road will be constructed on land currently owned by both Fire District 3 and Housing Authority.
- Planning for the road will be a cooperative effort between the parties in order to best meet the needs of all.
- Planning for the road will be managed and paid for by Fire District 3.
- Fire District 3 will pay for and complete the western half of the new access, including sidewalk, during development and construction of the Scenic Avenue Fire Station. The fire station is anticipated to be completed in the spring of 2020.

- Housing Authority will pay for and complete the eastern half of the new access including sidewalk during development, construction, and expansion of multi-family housing on their property. Development of their land is not anticipated for another three to five years.
- Fire District 3 will transfer ownership of any land leftover on Tax Lot 4600, on the east side of the new road, to Housing Authority. This transfer will commence when the Housing Authority completes the construction of their portion of the road.
- School District 6 will transfer Tax Lot 4400, to Fire District 3 (see map 1). The process for transfer will commence immediately in order for Fire District 3 to properly develop the land for the new fire station.
