PERMIT IS NOT VALID UNTIL REGISTERED THROUGH COMMUNITY CONNECT

This permit is free of charge and must be kept on site during any open or barrel burning. Please read this document completely to ensure that you are following the required regulations.

YOU <u>MUST</u> CALL THE SOUTHERN OREGON BURN LINE TO DETERMINE IF IT IS AN OPEN BURN DAY (541) 776-7007

- Your ability to burn is dependent upon: burn day restrictions, your location relative to the Air Quality Maintenance Area (AQMA), and current weather conditions.
- To determine your location with the AQMA, go to www.jcfd3.com and select "Burn Permits" to search by address. The AQMA is designated by diagonal lines on the map.

NO BURNING IS ALLOWED DURING FIRE SEASON

YOU ARE CIVILLY AND CRIMINALLY RESPONSIBLE FOR ANY FIRE THAT ESCAPES FROM YOUR BURN.

Open Debris Burning Required Check List

- Call burn line (541) 776-7007 before and check for hazardous weather conditions
- □ Working water hose <u>or</u> 5 gallons of water in bucket(s) <u>or</u> 4A rated fire extinguisher
- Shovel or rake
- □ An able-bodied adult in attendance at all times
- \Box Fire is to be extinguished by dark

Open debris piles shall only burn:

- Dry vegetative material
- Clean wood and lumber

(no railroad ties, painted, or pressure treated wood)

Fire Area Construction:

- Fire pits shall be lined by rocks or non-combustible materials. Manufactured outdoor fire pits are allowed, following manufacturer guidelines. It does not have to be a burn day to have a recreational fire.
- **Burn Barrels** shall be made of metal and have a metal screen on top (holes less than 1/8" in size). Barrels shall be kept in good condition

Recreational Fires shall only burn:

- Charcoal briquettes
- Dry cut firewood
- Clean, non-treated lumber

Sizes and Clearances:

- All burning shall have 25ft clearance from other combustibles or hazards.
- **Debris Piles Size** up to 3ft wide and 2ft tall, and shall be at least 25ft from any structure
- Burn Barrels and Chimineas shall be at least 25ft from any structure

IF YOUR FIRE GETS OUT OF CONTROL, CALL 911!

REQUIRED CLEARANCES RECREATIONAL FIRES 25 FT **DEBRIS BURN PILE BURN BARREL** MUST HAVE A SCREEN MAX = 3FT WIDE X 2 FT TALL **REQUIRED TO BE ON HAND 25 FT. DISTANCE** FROM STRUCTURES, TREES, **OTHER PILES, OR HAZARDS**
